- Complete and lodge the Application Form not less than 21 days prior to the event;
- Pay the prescribed permit fee PLUS GST;
- Be aware of the financial costs involved with running a Promotion and be capable of meeting these costs;
- Be familiar with the *Professional Combat Sports Act 1987 and Regulations 2004* concerning promoters and promotions; AND
- Agree to abide by the decisions of the Western Australian Professional Combat Sports Commission.

Incomplete applications will be returned unprocessed to the applicant.
